**Product Description:** ChemVantage is an LTI app for teaching and learning college-level General Chemistry. The vendor website is <a href="https://www.chemvantage.org">https://www.chemvantage.org</a> where instructors can learn about the product and school IT administrators can learn how to register ChemVantage in the institution's learning management system (LMS) using the LTIv1.3 standards. Students and instructors access ChemVantage content from inside the LMS by activating a launch link. Assignments are based on adaptive dynamic web content drawn from more than 10,000 question items. Upon completing each assignment (quiz, homework, practice exam, etc.), ChemVantage returns the student's score to the LMS grade book.

**Evaluation Methods Used:** The product was evaluated by following 8 separate workflow journeys, one for each of the 8 different assignment types offered:

- Quiz a timed informal summative assessment of a topic
- Homework an assignment of 10-20 quantitative question items designed to promote problem-solving skills
- **Practice Exam** a timed practice summative assessment designed to prepare students for a proctored exam on 25-50% of the course material
- Placement Exam a pre-course assignment designed to assess student readiness to take a college-level General Chemistry course
- **SmartText** combines a chapter reading assignment with a formative assessment of the student's knowledge of the chapter content
- Video Quiz combines a short video lecture on one key concept with embedded quizzes that ensure that students are retaining the knowledge content provided
- **Poll** an in-class assignment where students respond to question items in a collaborative environment and see aggregated statistical results for the class.

• Sage - a chemistry tutoring app powered by generative AI in which the student and AI collaborate to solve a series of increasingly challenging problems to demonstrate mastery of up to 146 key concepts in General Chemistry

For each of the 8 assignment types, the evaluation involved launching the assignment, completing the assignment in a student role using only keyboard navigation, and reviewing the assignment results. At each stage of the assignment, the HTML source code produced by ChemVantage was copied and pasted into a static web page and evaluated against WCAG accessibility standards using the free tool at <a href="https://accessibe.com/accessscan">https://accessibe.com/accessscan</a>. A total of 32 pages (3-6 pages per assignment) were evaluated and code modifications made until all 32 pages passed 100% of the tests in the access scans.
